INDEPENDENT PRACTITIONERS' REVIEW ENGAGEMENT REPORT

To Chief and Council of Yaqit ?a·knuqti'it

We have reviewed the accompanying Schedule of Remuneration and Expenses of Unelected Senior Officials of Yaqit ?a·knuqti'it for the year ended March 31, 2020 and other explanatory information (together "the schedule"). The schedule has been prepared by management in accordance with the requirements of the Indigenous Services Canada ("ISC") Reporting Guide.
